WITH INTERNSHIP

WELCOME TO OUR DEPARTMENT OF COOPERATIVE STUDIES

With approximately 10 000 registered students, the Berlin School of Economics and Law is one of the largest higher education institutions in Germany's capital city.

At the Department of Cooperative Studies, we currently have over 2000 enrolments. Our department offers special study programmes that combine full-time classroom study with regular, practical on-the job training. This dual structure of studies allows for applied learning and the acquisition of a broad range of professional skills, including social and methodological competencies, mainly in the field of business-related subjects, but also in a number of technical disciplines. A total of 650 companies cooperate with the Berlin School of Economics and Law by functioning as on-the-job training partners during the practical phases of study.

The Berlin School of Economics and Law has always maintained an international approach as an integral part of its vision and a key component in its higher education programmes and research. Through student exchange programmes run by the Department of Cooperative Studies, we aim to give foreign/incoming students the possibility to experience the integration of theory into practice and gain deeper insight into working life in Germany. We currently offer two exchange programmes in the field of Business Administration: Berlin Study Semester and Berlin Study Plus.

BERLIN STUDY SEMESTER

DETAILS

- 12 weeks of study in different business programmes
- English stream:
 - Soft skills (e. g. intercultural communication)
 - General modules Economics/Business Administration (e. g. Management)
 - Specific modules in the areas Service Management, International Business, Logistics & Transportation
- Optional participation in German modules of our regular business study programmes (e. g. Tourism, Trade and Industry, Facility Management, and Banking)

CREDITS

- max. 28 ECTS

Please note, the dual study format requires a comparatively high workload.



BERLIN STUDY PLUS

COMBINED THEORY-PRACTICE SEMESTER BASED ON COOPERATIVE STUDY PROGRAMME

DETAILS

- 12 weeks of study in different business programmes (see Berlin Study Semester)
- Participation in a German Language Course (strongly recommended)
- 8–12 weeks of internship in one of our partner companies

THE INTERNSHIP

- High quality internships with project work in close cooperation with partner companies
- Documentation of project supervised by a lecturer from the Berlin School of Economics and Law
- Internship seminars to reflect application of theoretical contents
- Credits granted for internship and project-related assignment.

CREDITS

- Theory Phase: max. 28 ECTS
- Internship + Project Paper / Internship Seminar: max. 14 ECTS
